

MONTREAL *DOUBLE DOUBLE*

The 2017 Montreal Double Double is presented by Adirondack Ultra Cycling. Complete and sign this form and send it in with all fees. Make checks payable to Adirondack Ultra Cycling and mail to: 7 Pearl Street, Schuylerville, NY, 12871. All funds must be in US dollars. Online registration is available at: www.bikereg.com/montreal-double-double. This event is limited to 16 riders and the entry deadline is July 15th, 2017 and day of event registration will not be available.

All participants must be over 18, unless accompanied by their parent or legal guardian. This event crosses the international border between the United States and Canada. All participants must have the proper paperwork to meet border crossing requirements. Exact itineraries, including cue sheets, hotel information, start times and locations, itineraries and other details will be sent to all registered riders with their confirmation package, usually when the event sells out, or after registration closes.

New for this year, we are also offering each riding day as a separate ride option. Your entry fee includes at least the following: two rest stops on each riding day with snacks and drinks, limited emergency sag support and gear shuttle. If you sign up for the full Double Double, overnight accommodations for both nights in Montreal and a buffet breakfast on Saturday are also included. Riders are expected to be properly prepared and self sufficient on the road. We will provide support as necessary, but we can't be everywhere at once, and there will be long stretches without services.
